Anytown's existing public safety and emergency services land mobile radio (LMR) communications equipment infrastructure is being operated beyond the manufacturer's end of life period, making it obsolete and unserviceable. The Town's critical radio communication infrastructure which supports law enforcement, EMS, fire department, and emergency management requires replacement. The Town is challenged by many factors including: varied topography, adjacency to a large body of water, and a complex built urban environment on the Anytown University campus which often hosts large state and regional events. These factors have contributed to situations where the conventional radio communication system has failed to provide reliable service coverage for emergency responders. In addition to being antiquated, the current communication technology is no longer meeting the needs of the community. Durham is susceptible to P25 APCO errors, which cannot be resolved without employing a newer generation of radio equipment technology to provide an Internet Protocol (IP) interface. Anytown requires a radio communication infrastructure rebuild utilizing modern technology to construct a more robust communications system to serve the public safety agencies which protect the community.

Anytown and Merrimack County government are collaborating with Radio Supplier Inc. with the understanding that Anytown and Merrimack County are determined to build a communications system that their users can trust, and firmly believe that Radio Supplier Inc. will accomplish that. The estimated project cost is \$808,893 and can be started immediately and constructed over a twelve to eighteen month period. The Town has invested in project engineering and a vendor has prepared contract documents. The project is shovel-ready pending funding.

This communication system overhaul investment will directly impact the local community and Merrimack County by increasing the reliability and performance of the emergency radio communications system for first responders in surrounding communities where Anytown public safety assets provide mutual aid and assistance regularly. Investing in critical communications infrastructure benefits the Town, University, and surrounding communities by ensuring a resilient first responder communication network, ensuring that radio communications will be fully functional both for daily operations and when required to be scaled up to address a significant emergency incident.
